- Chiefs Report Chief Sharp briefed the Board
  - Situational awareness with DEM. No creditable threats but in touch with DEM and are emergency managers are coordinated and connected if need be.
  - FBC has gone very well. Public meetings completed. Council, advisory committees. Getting a positive response. Lots of calls and email. Responses have been positive. Fingers crossed that the community will look favorably. No validation required for this vote. We should know by 8:15.
  - o With Commissioner Sheeran resigning. Board requirements are:
  - 42.12.080 requires the Board to nominate at least one candidate. Posted in News Paper for at least 15 days. Others in the community can put their name in. After the 15 days the Board will choose a candidate to fill the spot for the remainder of the 2025 term. Timeline to propose. The Board wouldn't select a candidate until December 3<sup>rd</sup>. Start the process and put notice out. Come back in January and take action and still be in the 90-day window. Decision has to be made by the second meeting of January.

Chair Dalton commented to the Board that Dan Rankin is willing to come back if needed to fill in if needed. Commissioner Casebolt asked who would receive the nomination. Director Wick would receive those nominations. She will receive and distribute to the Board.
